

RESOLUTION NO. 2019-901

RESOLUTION DECLARING THE CITY'S INTENT TO SET, POST AND PUBLISH A 4TH AND 5TH PUBLIC HEARING FOR CITY OF ARANSAS PASS' PROPOSED PHASE 2 ANNEXATION INTO THE TERRITORIAL LIMITS OF THE CITY OF ARANSAS PASS CONSISTING OF UP TO 1,400 ACRES OF LAND LOCATED NORTH OF ARANSAS PASS AND EXTENDING UP TO THE CITY OF ROCKPORT'S EXTRATERRITORIAL JURISDICTION, AND ALONG HIGHWAY 35 BYPASS AND HIGHWAY 35 BUSINESS.

WHEREAS, on April 15, 2019, the City Council adopted Resolution No. 2019-888 declaring the City's intent to begin annexation of up to 1,400 acres of land into the territorial limits of the City of Aransas Pass, directed the City Manager to prepare a service plan for the extension of municipal services to the proposed annexation area, and setting, posting, and publishing two public hearings on the annexation. Said proposed annexed area is depicted in Exhibit "A" and incorporated herein for all purposes ("Phase 2-Proposed Annexed Area").

WHEREAS, State law requires the City to conduct two public hearings at which persons interested in the annexation are given the opportunity to be heard;

WHEREAS, the City has set, posted, published and conducted three public hearings on May 17, 2019, May 18, 2019, and June 17, 2019 for the Phase 2-Proposed Annexed Area;


WHEREAS, the City intends to set, post, publish and conduct a 4th and 5th public hearing at which persons interested in the Phase 2-Proposed Annexed Area are given the opportunity to be heard.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF ARANSAS PASS THAT:

1. The City Council continues to declare its intent to annex the territory depicted in Exhibit "A" attached hereto and incorporated herein, consisting Phase 2- Proposed Annexed area, which consists of up to 1,400 acres lying adjacent to the City of Aransas Pass, Texas into the territorial limits of Aransas Pass, Texas.
2. In accordance with Texas Local Government Code, Section 43.065 the City Council continues to direct the city staff to prepare a service plan that provides for the extension of municipal services to the annexation area.
3. In accordance with Texas Local Government Code, Section 43.063, the City Council hereby schedules two additional public hearings on this annexation on July 22, 2019, at 12:00 P.M. and 6:00 P.M. in the Aransas Pass Civic Center, 700 West Wheeler Avenue, Aransas Pass, Texas. This is the nearest suitable public facility located outside the proposed annexed area.
4. The provisions of this Resolution shall become effective immediately upon final passage and approved by the City Council.


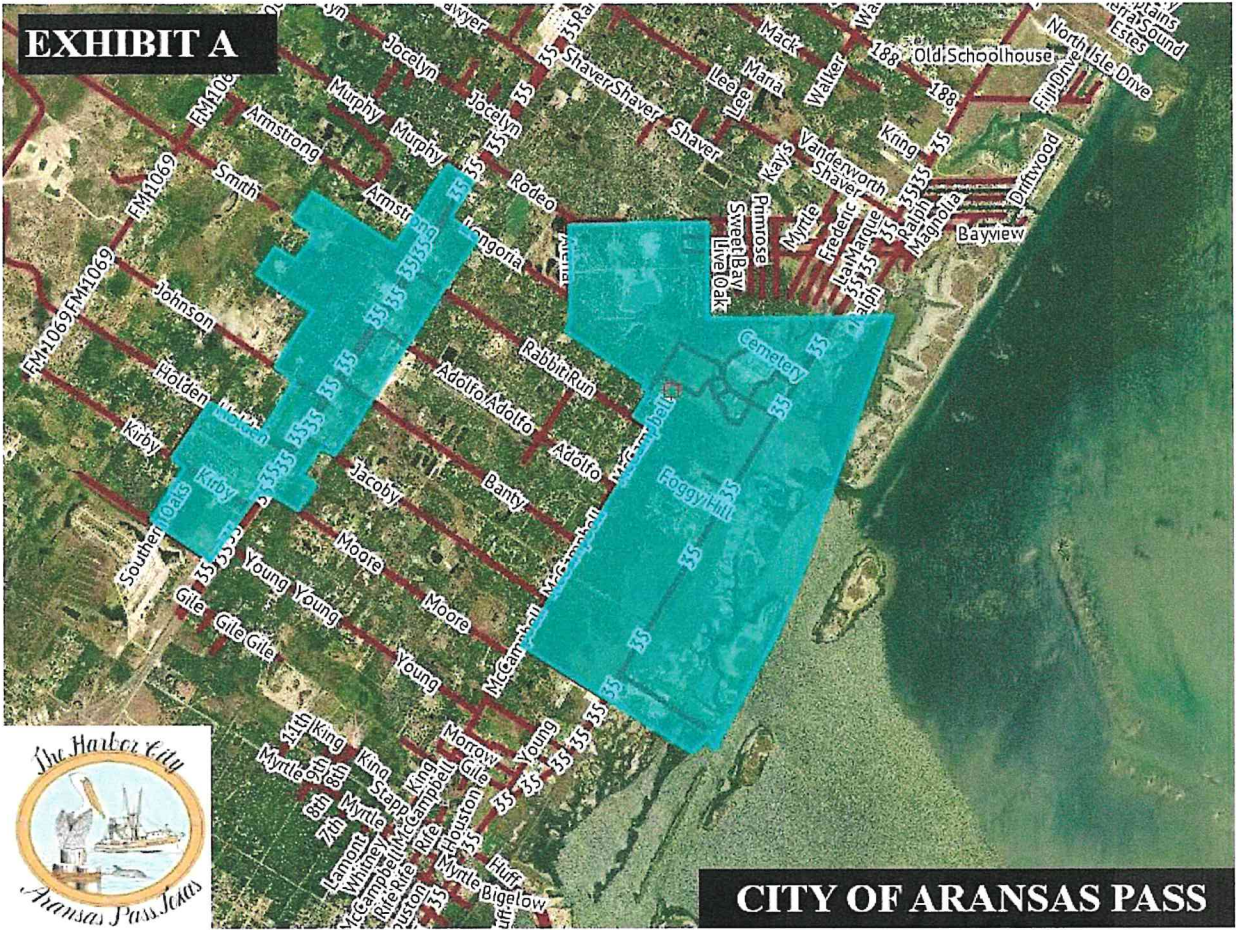
